

# FARADAY COPPER CORP HEALTH, SAFETY, ENVIRONMENTAL AND COMMUNITY (HSEC) POLICY

(adopted by the Board of Directors on August 23, 2022)

## 1.0 Purpose

Faraday Copper Corp and its subsidiaries (collectively, "**Faraday**" or the "**Company**") are committed to the implementation of a comprehensive Health, Safety, Environment and Community (HSEC) Policy (the "**Policy**". The mission of Faraday is to support the global energy transition and promote a sustainable future through the responsible development of its projects by cultivating a culture of safety and well-being, environmental stewardship and maintaining its social license through community engagement and support.

The purpose of the Policy is to address and communicate Faraday's commitments in these areas which align with the Company's core values.
